It has been felt necessary that Bhadratha, Arogya Bhadratha and Welfare wing of TS Police Department should equip with a Website and process of automation by extending on-line facilities to the Units and Members and also upgrade the existing software for utmost convenience of the beneficiaries of the Welfare Schemes. The D.G.P. TS who is the Chairman of the above Schemes was kind enough to accord permission to develop a Website and with his approval M/s iNative Tech Solutions Pvt. Ltd. Madhapur, Hyderabad, have been entrusted with the task of developing a new Website.

In pursuance of the above, for on-line updation of Bhadratha, the membership profiles of the Police personnel have been updated by the members in the Website and thereafter Hands-on-Training was given to all the A.Os/Managers/Bhadratha Clerks/IT Core team members, Nodal Officers and Clerks looking after Welfare work in the units in phased manner at Hyderabad.

Initially, it is proposed to go on-line for "Test Live of Bhadratha Website" with the nomenclature i.e., "telanganapolicewelfare.org" w.e.f. 01-01-2019 onwards on the following modules.

- 1) Personal loans
 - 2) Daughter Marriage loans
 - 3) Educational loans
 - 4) House Building Advances i.e., Purchase of Plot/Ready Built House/Ready Built Flat
 - 5) Settlements i.e., Retirement and Death Settlements and
 - 6) Subscriptions and EMIs of Loans
- All the applications in respect of the above loans and Settlement cases should invariably be applied by the members through On-line only and thereafter the physical copies of the applications with enclosures are to be forwarded to this office for further processing.
- The applications forwarded to this office without applying through on-line will not be entertained w.e.f. 01-01-2019.
- The Schedules pertaining to Subscriptions and EMIs of Loans of the members working in the respective units should be sent through on-line only
- The user manuals of all the above said loans are available in the Website i.e., "telanganapolicewelfare.org" for use by the members while making applications through on-line.
