Arogya Bhadratha w.e.f.01/12/2018-Instructions issued-Reg.

The Government of Telangana introduced Employees Health Scheme to all Government employees and their dependants, pensioners (excluding Police Department employees) in the reference 1st cited.

2. The Government also prescribed a tariff to be adopted by the Hospitals vide in the reference 2nd cited. However these rates were not made applicable to the members of Arogya Bhadratha and their dependants. After studying the tariff prescribed in the G.O. the Government was requested in this office letter dated 03/08/2017 and 11/04/2018 to extend the same tariff applicable to the Arogya Bhadratha Scheme. The Government after careful examination of the matter agreed to extend the tariff applicable to the EHS Scheme to the beneficiaries of the Arogya Bhadratha Scheme also vide reference 3rd cited.

3. In view of the orders issued by the Government extending the EHS Tariff to the Arogya Bhadratha beneficiaries it is decided to pay the tariff prescribed in the reference 2nd cited to all the empanelled hospitals under Arogya Bhadratha w.e.f.01/12/2018.

4. All the Managements of the hospitals are requested to enter into a new MOU with Arogya Bhadratha Scheme and to provide treatment to ABS members, their families and dependents and to charge the rates prescribed in the G.O.Ms.No.97 HM &FW (A2) Dated 07/06/2017 w.e.f.01/12/2018 upload the medical bills on our website within 15 days from the date of discharge and to submit the hard copy in this office for scrutiny of bills by medical officers of ABS to arrange payment as early as possible.
