

It is to state that vide reference 2nd cited above, the DGP / Chairman – Bhadratha had enhanced the HBA/Foreign Education loan limits for the benefit of the members from 01.07.2021 subject to the Take Home Pay not falling below 1/3rd of Gross Pay. The Chairman / DGP had also agreed to reduce the rate of interest on HBA Loans from 7.50% to 6.50% w.e.f. 01.07.2021 to the existing as well as fresh loanee members with prospective effect only.

Bhadratha will communicate the revised EMIs on the outstanding balances of HBA Loans from 7.50% to 6.50% to the existing loanee members only after 01.07.2021 as the reduced rate of interest will be implemented from 01.07.2021 onwards. The members who have taken all the three installments of HBA Loans are not entitled to get the enhanced loan limits.

Sub:- Bhadratha – sanction of various loans to the members – Forwarding of loan applications both soft and hardcopies by the units – Certain instructions – Reg.

It is to state that most of the Unit Officers are forwarding the loan applications of members by the month end instead of forwarding them as soon as the applications received from the members. Due to which, the processing of loan applications in Bhadratha office is causing abnormal delay.

The Unit Officers are therefore requested to issue instructions to the concerned dealing officers/clerks to send the loan applications through soft and hard copies immediately on receipt of the applications instead of keeping them pending till the month end and sending all the applications in a bunch to the Bhadratha office to avoid delay of processing the loan applications. If all the applications would be received in time from the Unit Officers, it is possible for processing of loan applications by the month end and circulates the file for sanction to the DGP / Chairman-Bhadratha in the 1st week of the succeeding month, so as to get the sanctioned loan amount by the members in time.
